Letter from the President & CEO

Dear Friend of Together,

Thanks to your support, Together accomplished amazing things in 2023. More than 22,000 individual participants visited our Choice pantries in Omaha and Council Bluffs, taking home nearly 2.4 million nutritious meals. Meanwhile, more than 1,700 people approached us with a housing crisis. With the help of our Crisis Engagement team, our Horizons Rapid Re-Housing program, and our Short-Term Emergency Housing Program, 864 of those were able to secure or retain housing. Your generosity is literally putting food on the table and a roof over the heads of our neighbors in need. Together also deeply appreciates the dedication of the many volunteers who help us serve our participants. In 2023, 2,197 volunteers recorded a total of 4,394 hours of service to our neighbors at our two Choice pantries.

All those efforts will continue in 2024, and there are exciting new initiatives on the way:

- Together is partnering with several other area nonprofits to open a Housing Stability Clinic, which will provide "one-stop shopping" for participants facing multiple challenges in obtaining or retaining their housing. The clinic will operate out of the old 11worth Café building, now owned by Together, at 2419 Leavenworth Street. Look for more information about this program, coming soon.
- In September, our Choice food pantry in Council Bluffs will move to a beautiful new location on the Lakin Human Services Campus.
- And toward the end of the year, Together will launch a new Permanent Supportive Housing program, which will allow us to continue working on an ongoing basis with participants whose disabling mental and physical conditions make difficult for them to find or keep a safe place to live.

Our internal data suggests that hunger and homelessness continue to rise in our community but, as these new programs demonstrate, Together remains committed to developing innovative ways to address these stubborn problems. I remain hopeful, and I deeply appreciate your continued support, which enables us to do this vital work. Your generosity is a lifeline to all those we serve.


